#### **OUR STORY**

Founded in 1971, as San Francisco's first shelter designed for entire families, Raphael House set a new standard of care. Since then, we have continued to offer a supportive environment that respects the dignity and potential of every parent and child who walks through our doors.

Today, we assist approximately 800 individuals annually, providing wraparound comprehensive services that include housing support, career development, children's programming and academic assistance, financial education, and case management.

Our programs are grounded in a long-term commitment. Families can access services through our Bridge Program for up to 18 years after leaving shelter. In the past 10 years, an average of 87 percent of families in our Residential Shelter have transitioned into stable housing, and 93 percent have maintained that stability through our Bridge Program.

Throughout recent challenges such as the COVID-19 pandemic, Raphael House remained open and responsive to the evolving needs of families. We adapted our services to meet new demands, including expanded financial assistance and virtual programming, ensuring uninterrupted support during times of crisis.

None of this work would be possible without the generosity and dedication of our community. Donors, volunteers, and partners continue to power our programs and walk alongside our families every step of the way.

Now, as Raphael House enters a new era, we do so with clarity, momentum, and hope. Our mission remains unchanged, and our resolve has only deepened. With your support, we will continue to adapt, grow, and build a stronger future for families across the Bay Area.

### THE RAPHAEL HOUSE FAMILY JOURNEY

#### 1. Moving In

Each family we serve is referred to Raphael House through San Francisco's Department of Homelessness and Supportive Housing's Coordinated Entry Access Points located throughout the city, which serve as community gateways into the city's Homelessness Response System. Over the past 10 years, an average of 44 families are welcomed to Raphael House each year, and many of our families are headed by single moms.

#### 2. Our Residential Shelter

Our Residential Shelter provides families with a safe, stable, and welcoming environment. After the referral and intake process, each family receives a private, fully furnished room, three nutritious meals per day, clothing, and other essential supplies. Families typically stay with us for a minimum of four months, with extensions granted on a case-by-case basis depending on individual needs and circumstances. While in shelter, families work closely with case managers and participate in services that strengthen family bonds, address barriers to housing, and support long-term financial independence.



#### 3. Moving Out

In 2024, 82% of Residential Shelter families transitioned to long-term, stable housing. When leaving our shelter, our case managers connect our families to local resources and help ease the transition by providing direct aid such as assistance with moving expenses, new clothes, and apartment kits that include essential supplies for a fresh start.



#### 4. Our Bridge Program

Our unique Bridge Program ensures that families continue receiving support after exiting shelter, with services available for up to 18 years. This long-term connection helps families stay housed, financially stable, and supported through life's changes. Services are flexible and relationship-based, designed to meet the evolving needs of each family. Last year, 95% of engaged families in our Bridge Program maintained their stable housing.

#### **CASE MANAGERS**

Each family in our Residential Shelter Program is assigned a case manager who acts as their advocate, ally, and coach throughout their stay. In addition to helping with any immediate needs, the case manager collaborates with the family to develop a long-term plan for securing a stable income, arrangements for childcare and education, and permanent housing.

#### **CHILDREN'S SERVICES**

On average, children experiencing homelessness have a lower chance of graduating high school, with higher rates of chronic absenteeism. Raphael House believes every student should have the best resources for success, and through our K-12th grade tutoring services, our staff provides intensive one-on-one assistance to help students improve their academic performance and social-emotional learning. Last fiscal year, 100% of participating students showed academic improvement, and 100% showed improvement in their socio-emotional behaviors.

# OUR IMPACT FISCAL YEAR 2024

#### **OUR STORY CONTINUES**

Raphael House remains one of the few family shelters in the Bay Area focused on addressing the persistent and growing crisis of family homelessness. A growing body of research and data confirms what Raphael House has known for decades: housing alone is not enough to help those facing homelessness, but it is the first critical step. That is why our model offers holistic, long-term support tailored to each family's unique strengths and needs.

The need for our services has never been more urgent. According to the 2024 San Francisco Point-in-Time (PIT) Count, 405 families were experiencing homelessness, a 94 percent increase since 2022. Of those families, 130 were unsheltered, meaning they were living on the streets, in vehicles, or in places not meant for habitation. These numbers likely underrepresent the true scope of the issue. PIT counts often miss families who are temporarily staying with others, living in motels, or sleeping in their cars. While 8,323 individuals were counted as homeless on a single night, it is estimated that more than 20,000 people access homeless services in San Francisco over the course of a year. For every person who finds stable housing, three more become unhoused.

These families are often navigating multiple overlapping barriers to housing and financial stability, including lack of affordable childcare, barriers to education, domestic violence, language barriers, underemployment, and immigration-related legal issues. At Raphael House, we believe no family should face these challenges alone, which is why we provide a seamless customized experience for our families navigating through these complexities with our comprehensive support programming. The challenges are real, but so is the progress. Thanks to our dedicated staff, resilient families, and the incredible community that surrounds us, Raphael House continues to meet this moment with compassion, consistency, and care.

#### **OUR STORY CONTINUES**

Fiscal Year 2023–24 marked a turning point for Raphael House. Like many nonprofits, we felt the continued ripple effects of the pandemic, shifting funding landscapes, and rising operational costs. In response, we began expanding our funding base preparing us to secure public support in FY25, while continuing to prioritize the community-based model that has sustained us for over 50 years.

Despite these challenges, we closed FY24 in a strong position. The sale of an underutilized building provided a strong boost to our financial position and our Black & White Gala raised a record-breaking \$1 million — our highest-grossing event to date. These milestones helped reinforce a critical reserve, ensuring we can sustain core programs and adapt to future needs.


In FY24, Raphael House remained entirely community-funded, with most of our support coming from individuals, corporations, and foundations. Fundraising efforts, including events and donor engagement, are essential to advancing our mission and are reflected in our development expenses.


Our programs are designed for deep, long-term impact. In FY24, families stayed an average of 4.7 months in our Residential Shelter, receiving tailored support like case management, career development, and financial literacy services. After exiting, families continue to access services for up to 18 years through our Bridge Program. Managing this level of care requires thoughtful investment in staffing, facilities, data tracking, and compliance, which is reflected in our administrative expenses. Administrative costs also include financial oversight, technology, training, and regulatory compliance, in addition to the backbone of strong management. These functions are essential to ensuring families receive high-quality, consistent care and that we remain accountable to both funders and public partners.

We also undergo an annual independent audit to ensure transparency and accountability. Despite operating in one of the most expensive cities in the country, nearly two-thirds of our total expenses go directly to programs that serve families. Thanks to the generosity of our community and careful financial planning, Raphael House remains well-positioned to continue delivering family-centered services that foster long-term stability, independence, and hope.
